The Space Coast Women In Defense (SCWID) has been working diligently to enhance Science, Technology, Engineering and Mathematics (STEM) in our Space Coast community since our inception in January 2013. On Friday, April 21, 2017 we will host our second annual Space Coast STEM Sandbaggers Invitational Golf Tournament at the Duran Golf Club, Viera FL. The main purpose of this event is to raise funds for Brevard County STEM programs.

Dear Sir or Madam:

We have received the information you recently submitted concerning your articles of merger of National Security Industrial Association into American Defense Preparedness Association, both District of Columbia Non-Profit Corporations, and your continuing exemption from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986. The surviving corporation's name was changed to the National Defense Industrial Association.

The changes indicated in your letter of January 30, 1998, from Mr. Roger C. Ohlrich, explaining your merger which became effective on March 1, 1997, pursuant to your merger agreement of February 26, 1997, does not adversely affect your exempt status under section 501(c)(3) of the Code, and the determination letter issued to you in April 1988, continues in effect. You may rely on this letter until your exemption is terminated, modified, or revoked by the Internal Revenue Service.

Please let us know about any future change in the character, purpose, method of operation, name or address of your organization. This is a requirement for retaining your exempt status.
